Student Financial Assistance

Contains basic financial aid information including 1) assistance available from federal, state, local and institutional programs, procedures to apply, and forms for applicants; 2) federal student financial aid penalties for drug law violations; 3) how cost of attendance budgets are calculated; 5) provisions for books and supplies policy for eligible students including textbook information; 6) requirements, if selected for verification; 7) satisfactory academic progress (SAP) for financial aid students; and 8) student loan information including entrance and exit loan counseling for student borrowers, and code of conduct for education loans.
